

BUNKER AND SLUDGE TRANSFER PROCEDURE & GUIDELINES

All Bunkering and desludging operations are to follow Oil Bunkering Best Practice Guidelines. Please refer to IMO's 'Manual on Oil Pollution, Section 1 Prevention" as amended, and the ICS and OCIMF 'Ship to Ship Transfer Guides'.

Definitions

Shipping Agent

A person or organization responsible for the administrative details of a ship, on behalf of the ship owner or charterer, during the ship's visit to the port.

Berth

Any dock, jetty, quay, or place within the SOHAR Port Concession area where a ship may be secured.

Bunker transfer

Means the transfer of bunker oil, a flammable/combustible liquid intended for the propulsion and or the auxiliary operation of a ship, or a liquid intended for lubrication the ships engine or machinery.

I.M.D.G

International Maritime Dangerous Goods code

Sludge transfer

Means the transfer of residues from fuel and or oily water taken from the engine room or another bilge area on a ship by the marine waste collection barge.

PCC

Port Coordination Center

OMWT:

Oman Maritime Waste Treatment SAOC, being the Port Reception Facilty for the disposal of MarPol waste.

OOT

Oiltanking Odfjell Terminals & Co. LLC

MSO

Port Authority Marine Safety Office



REQUIREMENTS FOR SHIPS

Shipping Agent:

- Notification of the intention to bunker is to be provided to the Sohar PCC, detailing the quantity and type of oil by filling in the Dangerous Goods and Bunker Notification form.
- Notification of the intention to dispose sludge or other liquid Marpol waste is to be provided to SOHAR PCC and also to the Port reception facility(OMWT), detailing the quantity and type of waste by filling in the Waste Disposal Notification form.
- Both forms must be signed and stamped by the Master.
- Terminal approval for the operation (if during alongside phase) should be provided together with the form by agent.
- The completed form and other attachments must be e-mailed to Sohar PCC at least 24 hours prior to the vessel's arrival.
- The form, when received will be processed by the PCC after which consent will be given back to the agent by email.
- As soon as consent is given by the PCC, the agents has to plan the operation with the bunker supplier or the Port Reception Facility (OMWT).
- The agent will inform the master of his duties and responsibilities as mentioned below.
- The ship's agent will notify the ship's master of his responsibility to contact PCC by VHF channel 71 one hour prior to their intention to bunker or sludge transfer operations.

Ship's Master:

- It is the responsibility of the ship's master to comply with SOHAR bunker and sludge transfer procedures and instructions given to him by the PCC or the agent on behalf of the PCC.
- The ship's master must notify PCC by VHF channel 71, one hour prior to commencement of bunker or sludge transfer operations.
- The ship's master must take all necessary safety precautionary measures throughout the operation; the ship's master involved in the operations shall ensure that bunker and sludge transfer will only take place if:
 - o A bunkering / sludge disposal checklist has been completed truthfully and fully.
 - o The bunkering / sludge disposal checklist, as a minimum, should ensure the following points have been complied with:
 - The scuppers/wash port is firmly plugged/sealed.
 - Bunker / sludge connections not in use are well blanked.
 - The bunker / sludge connection has been provided with a good seal.
 - There is a well-tightened bolt in every bolt-hole at the used pipe connections.
 - There is a sufficiently large save all under the used pipe connections.
 - The hoses are well supported and are of sufficient length to allow for movement of the ship.
 - There is effective communication established and maintained by the ship's engineering crew, to enable immediate shutdown if required.
 - Any cargo handling in progress will not hinder bunker transfer operations.



Once bunkering or sludge disposal has commenced:

- There must be no smoking, naked flames or hot work is permitted during operations.
- A visual watch must be maintained throughout the entire transfer operation.
- Ensure that sufficient absorbent material is available on site to deal with any accidental spillage.

Spillage or any other incident

If a spillage does occur, all efforts must be made to stop or limit the spillage and the SOHAR Port and Authority must be immediately notified via PCC on:

If the SOHAR Port Authority Officer notices that any of the requirements laid down in this document cannot be fulfilled prior to or during bunker transfer then operations must cease immediately.

Bunker and sludge transfer can only start or restart when the Officer is satisfied that all requirements are being met.

Requirements for bunker barges or sludge barges:

The Master of a bunker barge or a sludge barge shall not begin transfer unless he has ensured that:

- The barge is securely moored.
- A bunker transfer and or sludge disposal checklist has been completed truthfully and fully.
- There is effective communication established and maintained by the barge, to enable immediate shutdown if required.
- The hoses are in good condition and certified in accordance with international standards.
- The hoses are well supported and are of sufficient length to allow for movement of the ship.
- There is a well-tightened bolt in every bolt-hole at the bunker pipe connection or Marpol flange.
- The connection flange has been provided with a good seal.

Once bunker and/or sludge transfer has commenced:

- This must be constantly watched and monitored throughout the entire transfer operation.
- Sufficient absorbent material is available on site to deal with any accidental spillage.
- If a spillage does occur, all efforts must be made to stop or limit the spillage and the SOHAR Port Authority must be immediately notified on:

If the SOHAR Port Authority Officer notices that any of the requirements laid down in this document cannot be fulfilled prior to or during bunker or sludge disposal transfer then operations must cease immediately. The transfer can only start or restart when the Officer is satisfied that all requirements are being met.



Requirements for bunker or sludge barge operations at OOT berths and jetties:

The following is an outline of the PoS requirements on the transfer of fuels or sludge between tankers and bunker or sludge barges at OOT berths and jetties in the SOHAR Port and Freezone. These requirements must be followed whenever possible and deviation should only be considered in consultation with OOT and SOHAR Authority.

In case of tankers handling cargoes with a flash point above 60 degrees Celsius and in inert condition:

 the Ship-shore transfer operations should be unaffected by bunker or sludge transfer operations.

In case of Tankers handling cargoes with a flash point below 60 degrees Celsius and/or Tankers not under inert conditions.

- Ship-shore transfer operations must cease for the period that the barge is alongside. This includes the bunker od sludge barge coming alongside and departing.
- Under no circumstances may a tanker, load, tank wash or vent products with a flash point below 60 degrees celsius during bunker or sludge transfer operations.

These requirements have been formulated with regard to the flash point of the cargo being handled, and do not apply any transit cargo that may be present.

Note

SOHAR Port Authority reserves the right to inspect all aspects of the bunker or sludge disposal transfer before commencement, and during the operations. Instructions given by the Port Authority should be followed immediately.
